Qtrac Ltd. (*Qtrac*) is the owner of **comparepdfcmd version 2.5.0-pe** (CPE).

CPE is for sale only to existing Qtrac customers in the US and some other countries.

The *purchaser* is the company or organization that purchases CPE.

The purpose of the CPE license is to provide a means by which Qtrac's customers may continue to use Qtrac's software even after Qtrac is wound up.

Qtrac hereby gives the purchaser a non-exclusive license to use CPE and its associated documentation under the following terms.

CPE may only be used under the terms of this license.

CPE may *not* be embedded as part of other software that is then given, rented, leased, sold, or otherwise transferred to a third-party. However, if the purchaser already incorporates comparepdfcmd within their own product as a component (i.e., OEM use), this license allows them to continue this practice using CPE providing Qtrac agrees to this use.

CPE's functionality is the same as comparepdfcmd version 2.4.2 except as follows. CPE does *not* use a license key; CPE does *not* have an expiry date; CPE does *not* check which computer it is running on. CPE is *not* affected by changes to the physical or virtual hardware (e.g., adding RAM or BIOS updates) or software changes (e.g., normal Windows updates). This means that CPE may be copied to and used on *any* physical or virtual computer (running 64-bit Windows 7, 10, or later), with *no license key being necessary*.

Within 48 hours of receipt of payment of the one-off non-refundable license fee, Qtrac will supply one copy of the CPE software in a .zip file. CPE will be made available to the purchaser in the Google Cloud ("G Drive"). The software received may be copied and used freely by the purchaser as per this license. In particular there is no limit to the number of copies that may be used, nor any limits on concurrent use on any mix of physical and virtual computers, provided they are used only by the purchaser (or on an OEM basis if agreed separately with Qtrac).

CPE may be copied for archival purposes, provided any copy contains all of the original software's proprietary notices.

Additional requirements/constraints:

- you may not use CPE to provide an online service (e.g., an online PDF comparison service, or a service that uses PDF comparisons) except on an intranet accessible only to the purchaser;
- you may not give away, rent, lease, sell, or otherwise transfer the CPE;
- you may not modify, translate, reverse engineer, decompile, disassemble CPE (except to the extent applicable laws specifically prohibit such restriction);
- you may not create derivative works based on CPE (except as specified above regarding embedding CPE);
- you may not give away, rent, lease, sell, or otherwise transfer rights to CPE;
- you may not remove any proprietary notices or labels on CPE.

Notice

comparepdfcmd version 2.5.0-pe is the final version of comparepdfcmd that will be sold. Purchases must be made by 2025-03-31; after that date none of Qtrac's software will be available for purchase. CPE will *never* receive any maintenance or updates and Qtrac is expected to be wound up in 2025 (due to retirement).

Termination

The license will terminate automatically if you fail to comply with any of the license's terms. On termination, you must destroy all copies of CPE and documentation.

Disclaimer of Warranty

CPE is provided on an as is basis, without warranty of any kind, including without limitation the warranties of merchantability, fitness for a particular purpose and non-infringement. The entire risk as to the quality and performance of CPE is borne by you. Should CPE prove defective, you and not Qtrac assume the entire cost of any service and repair.

Qtrac is not responsible for any indirect, special, incidental, or consequential damages of any character including, without limitation, damages for loss of goodwill, work stoppage, computer failure or malfunction, or any and all other commercial damages or losses.

Title, ownership rights and intellectual property rights in and to CPE shall remain in Qtrac. CPE is protected by international copyright treaties.
