Qtrac Ltd. (*Qtrac*) is the owner of **DiffPDF version 6.2.0-pe** (DPE).

DPE is for sale only to existing Qtrac customers in the US and some other countries.

The *purchaser* is the company or organization that purchases DPE.

The purpose of the DPE license is to provide a means by which Qtrac's customers may continue to use Qtrac's software even after Qtrac is wound up.

*Qtrac* hereby gives the purchaser a non-exclusive license to use DPE and its associated documentation under the following terms.

DPE may only be used under the terms of this license.

DPE may *not* be embedded as part of other software that is then given, rented, leased, sold, or otherwise transferred to a third-party.

DPE's functionality is the same as DiffPDF version 6.1.1 except as follows. DPE does *not* use a license key; DPE does *not* have an expiry date; DPE does *not* check which computer it is running on. DPE is *not* affected by changes to the physical or virtual hardware (e.g., adding RAM or BIOS updates) or software changes (e.g., normal Windows updates). This means that DPE may be copied to and used on *any* physical or virtual computer (running 64-bit Windows 7, 10, or later), with *no license key being necessary*.

Within 48 hours of receipt of payment of the one-off non-refundable license fee, Qtrac will supply one copy of the DPE software in a .zip file (and possibly a .msi file). DPE will be made available to the purchaser in the Google Cloud ("G Drive"). The software received may be copied and used freely by the purchaser as per this license. In particular there is no limit to the number of copies that may be used, nor any limits on concurrent use on any mix of physical and virtual computers, provided they are used only by the purchaser (or on an OEM basis if agreed separately with Qtrac).

DPE may be copied for archival purposes, provided any copy contains all of the original software's proprietary notices.

Additional requirements/constraints:

- you may not use DPE to provide an online service (e.g., an online PDF comparison service, or a service that uses PDF comparisons) except on an intranet accessible only to the purchaser;
- you may not give away, rent, lease, sell, or otherwise transfer the DPE;
- you may not modify, translate, reverse engineer, decompile, disassemble DPE (except to the extent applicable laws specifically prohibit such restriction);
- you may not create derivative works based on DPE (except as specified above regarding embedding DPE);
- you may not give away, rent, lease, sell, or otherwise transfer rights to DPE;
- you may not remove any proprietary notices or labels on DPE.

## Notice

**DiffPDF version 6.2.0-pe** is the final version of DiffPDF that will be sold. Purchases must be made by 2025-03-31; after that date none of Qtrac's software will be available for purchase. DPE will *never* receive any maintenance or updates and Qtrac is expected to be wound up in 2025 (due to retirement).

## Termination

The license will terminate automatically if you fail to comply with any of the license's terms. On termination, you must destroy all copies of DPE and documentation.
